License to play (publicly perform) music in conjunction with physical exercises (dancercise, aerobics, bodybuilding, and other similar activities) and dance instruction.

SOCAN Membership - January 01, 2021 to December 31, 2021

Only ADEA members in good standing can take advantage of the rate agreement between the ADEA & Entandem.

SOCAN FEES: \$80.00 / teacher (this amount includes GST)

PAYMENT DEADLINE: October 31, 2020

***NOTE: A 10% late fee will be added to all overdue accounts.**

Did you know:

- In 2019, SOCAN launched a licensing joint venture with RE:SOUND to simplify the music licensing process. Entandem administers general licensing on behalf of SOCAN and RE:SOUND.
- SOCAN fees must be submitted for ALL teachers on staff, with the exception of syllabus instructors.
- **If you have a teacher(s) that teaches for a non-member studio(s), please DO NOT divide their SOCAN payment. The ADEA cannot collect fees from a studio that is not a member of the Association.**
- It is NOT the responsibility of the ADEA to divide SOCAN fees for an individual teacher. If you wish to discuss division of payment between studios, please make those arrangements. ONE STUDIO WILL SUBMIT FOR THAT TEACHER.
- **It is the responsibility of individual studio owners to ensure that RE:SOUND fees are remitted directly to Entandem on or before January 31, 2021. Studio owners will receive a separate email with further information regarding Re:Sound.**
- **The ADEA will submit one cheque to Entandem for SOCAN fees on behalf of all ADEA Members (based on names of teachers provided).**
